

BIKE ACCESORIES RENTAL AGREEMENT

§ 1.

The subject of the agreement is cycling accessories, i.e. helmet, goggles, protective pads (hereinafter collectively as: "Accessories"):

§ 2.

§ 3.

1. The Rental Shop provides the Renter with the Accessories in a condition fit for the agreed use (visibly proper technical condition). The technical condition of the rented Accessories has been accepted by the Renter and checked by a Rental Shop employee.
2. The Renter declares that they externally inspected the Accessories and found no visible technical defects.
3. The Accessories shall be returned undeteriorated, excluding normal wear resulting from proper use.
4. The Renter must report to the staff any noticed damage or missing elements in the Accessories when they are issued and returned.

§ 4.

The Renter undertakes to use the Accessories as intended and bears full responsibility for any events and damage resulting from their use.

§ 5.

1. The Renter shall be liable for damage resulting from improper use of the rented Accessories and shall also cover all costs related to the repair of the Accessories according to an individual valuation made by the Rental Shop based on market prices.
2. The Rental Shop reserves the right to refuse to accept the Accessories when the damage is so significant that repair becomes uneconomical. In such a case, the Renter undertakes to cover the costs corresponding to the market value of the rented Accessories on the date the damage is identified, according to the valuation presented by the Rental Shop based on market prices.

§ 6.

1. Fees for the rental of the Accessories are calculated according to the Price List and collected in advance in cash or by payment card for the whole period in advance.
2. The rental agreement may be concluded for a whole day or a multiple thereof.
3. The Rental Shop reserves the right to charge compensation for non-contractual rental of the Accessories in the event of a delay in returning the Accessories, for each day, in the amount specified in the Price List.

§ 7.

In respect of liability for accidents and damage to the Accessories, the provisions of § 5 of the Regulations apply.

§ 8.

To matters not regulated in the rental agreement and the Rental Shop Regulations, the provisions of the Civil Code shall apply.

§ 9.

The agreement has been drawn up in two identical counterparts, one for each Party.

§ 10.

Information regarding GDPR is included in the Rental Shop Regulations.

§ 11.

By signing the Agreement, the Renter confirms that:

1. they have received and familiarised themselves with the Rental Shop Regulations and the Price List.
2. they have been instructed on the rules for safe use of the Accessories.
3. they acknowledge that riding in mountain terrain involves sporting risk and assume responsibility for damage resulting from their own mistakes or lack of skill.
